Sarah's job is to provide educational services or preschool-age children with special needs who are enrolled in community-based early childhood programs like yours. Itinerant early childhood services may be provided in homes, child care centers, home-based child care programs, preschools, kindergarten classrooms. Head Start classrooms, or any other early childhood setting. Sarah travels to a number of different programs to work with the children on her caseload and their teachers. Her visiting schedule varies depending on the needs of the children, but it is usually once a week for about an hour.

In her role, Sarah wears many hats – she is a consultant, a resource person, and a teacher. Her main responsibility is to work with the classroom teacher and/or child care provider, staff members, and families so that children with special needs can receive the most appropriate learning experiences. She also may spend time with children in their classrooms or homes as needed. She is available to provide suggestions, strategies, resources, and ideas to support the classroom teacher and/or child care provider. She and the teacher will work out a system so they can best work together. It will be important that they find some uninterrupted time each week when they can meet to discuss and share information.
